Your written entry should be no less than 500 words and should not exceed 1,200 words.

1. Your company

Tell us about your company and locally made product(s), include details on product quality, uniqueness and authenticity. How well does your product or service represent Canada's East Coast? (200-300 words)

2. Your strategy

Provide details of the diversity and inclusion strategies in place at your workplace. What issues do you believe can be solved through improved diversity and inclusion practices? Please explain your strategy and identify the opportunities for growth and development within your organization. (200-300 words)

3. Implementation & leadership

Who introduced, monitored and implemented your diversity and inclusion strategies? Please detail any roadblocks/issues/challenges you might have encountered and how you were able to overcome them. How are your team leaders held accountable for their commitment to diversity and inclusion? What ongoing support and resources are available to diversity and inclusion leaders on your team? (200-300 words)

4. Results

Tell us how the initiative has benefited your employees. How do leaders encourage your team to build an inclusive workplace? If possible, include feedback/ statements from employees. Also, show how the workplace has changed and improved at all levels of your workplace team. How has your business benefitted/ grown/improved from your diversity and inclusion strategies. (200-300 words)
